- To reduce air emissions other than greenhouse gases (SOx, NOx, VOC, PM, dust) and other atmospheric emissions such as odor, noise, light, road congestion and traffic resulting from logistics operations,
- Within the scope of waste management practices, preventing waste generation at source, reducing waste, recycling, collecting and disposing of the waste generated in accordance with regulations, ensuring the sustainability of the established Zero Waste Management System,
- To ensure that hazardous substances are effectively managed in a way that minimizes their impact on the environment and human health; to encourage the use of more environmentally friendly and low-risk alternative materials where possible,
- To carry out advocacy activities to raise public awareness on environmental issues; to lead collaborations and sharing of good practices to spread sustainable practices in our sector.

The Sustainability Committee, appointed by the Board of Directors, is responsible for the implementation of this policy. The Environmental Policy is reviewed by the Sustainability Committee at least once a year in terms of its currentness and effectiveness. Revisions deemed necessary are submitted to the Board of Directors for approval and put into effect. Once put into effect, it is published on the website and QDMS and made accessible to all stakeholders.
